Staff Report

Stating District Opposition to Dissolution

Glenn Lazof: Interim General Manager (IGM)

Background: LAFCO has submitted a Circulation Draft of the Municipal Services Review (MSR) of the District, on Friday May 26. This agenda item is an opportunity for Board of Commissioners to make a statement to the Community regarding their opposition to Dissolution of the District.

IGM Recommendation: Policy.

The following is from a press release by the President and Vice President, should the commission find this useful in crafting a motion. The San Mateo Harbor District Board of Commissioners strongly opposes the dissolution of this District. This agency intends to responsibly address LAFCo recommendations and will consider all recommendations carefully.

The District is further committed to bringing stability while implementing solutions for the efficient and continuous improvement of District operations. We are looking forward to an inclusive and constructive public dialogue that focuses on solutions. Our goal is to make the harbors thrive and have the District endure over time.

Fiscal Impact: None. At the direction of the Interim General Manager, Staff and Counsel began working in support of this goal shortly after release of the MSR Circulation Draft.

Staff Report

CONSIDERATION OF ENTERING INTO CONTRACT FOR LEGAL SERVICES WITH WITTWER-PARKIN LLC TO ASSIST WITH COMMENT LETTER RESPONDING TO DRAFT MUNICIPAL SERVICE REVIEW

Glenn Lazof: Interim General Manager

Background: LAFCO has submitted a Circulation Draft of the Municipal Services Review (MSR) of the District, on Friday May 26. The comment period ends June 26, 2014. President Mattusch, in consultation with the Interim General Manager and District General Counsel submitted memoranda to commissioners regarding the process to be used to prepare the District's official comments.

As should be expected, the IGM, initiated several activities shortly after the Circulation Draft was issued. These were designed to respond to the Administrative Draft MSR within LAFCO's deadlines. The Interim General Manager will continue to treat this issue as a priority unless directed otherwise by the Commission. Action taken from this report, other than those reflected in the first paragraph, include:

- o Initial Reviews by District General Counsel, Interim General Manager and other staff
- o Establish process for including Commissioner input into report
- o Scheduling, with the President (or Vice President as necessary)
- Opportunities to interview willing LAFCO Commissioners to gain insight into most effective responses
- O Contacting Partner Agencies who have worked successfully with the District for Letters of Support
- Legal and Staff reviewing past LAFCO MSR's regarding the Harbor District

As reported last week, District Counsel was reluctant to continue working on this item after the June 8th Special meeting was called. It was unclear whether that assistance was still supported by the Commission. Since that time, and not wanting to disrupt our response, the General Manager has continued to request this assistance, at least until directed otherwise by the Commission. At least one Commissioner has expressed the desire for General Counsel to not be our lead counsel in this matter. This Special Meeting provides another opportunity for the Commission to provide such direction.

Analysis: The Interim General Manager has confidence in the current plan, as described above, but also has no objection to adding another set of legal eyes to our response if the Commission desires.

A competitive procurement has not taken place; therefore, should the Commission elect to make this assignment, staff has submitted proposed findings to support an alternative

procurement procedure. Wittwer-Parkin, LLC appears to have a significant local government expertise. Below is a list of Wittwer-Parkin, LLC's other government clients from their website:

California Coastal Commission; City of Saratoga, Assistant City Attorney; Coastside Community Water District; County of Sonoma; County of Tulare; Fairbanks Ranch Community Services District; Granada Sanitary District, El Granada, General Counsel; Housing Authority of the County of Santa Cruz, General Counsel; Rancho Santa Fe Community Services District; Santa Clara County Open Space Authority, General Counsel; Spreckels Community Services District; Whispering Palms Community Services District.

Regarding our General Counsel, Hanson Bridgett has worked with San Mateo County LAFCo on numerous matters involving annexations, dissolutions, service-outside-of borders, and more. Clients on whose behalf of, report to have recently worked on matters of San Mateo LAFCo which include: San Mateo County Mosquito and Vector Control District; North Coast County Water District; Westborough Water District; City of San Carlos; City of Belmont; Harbor Industrial Area. Members of LAFCo are also Board members of agencies for which Hanson Bridgett serves as General Counsel or Special Counsel including San Mateo County Transit District, North Coast County Water District, and the City of Pacifica. The firm has also worked on annexation projects in counties outside of San Mateo County.

Interim General Manager Recommendation: Policy.

The Interim General Manager has no objection to obtaining additional assistance in our efforts to craft the best response if the Commission so desires. The Interim General Manager spoke with Jonathon Wittwer regarding an adequate not to exceed amount for collaborating with our existing efforts. We feel that 10 hours would suffice for review as well as allow for advising on strategy. Therefore, if the Commission elects to go this route, the recommendation is that your action include a not to exceed amount of \$3,000.

Staff continues to recommend <u>against</u> designating a new firm as lead counsel on this matter, even more so now that more of the allotted response time has passed since the June 8th Special Meeting.

Procurement Findings: (Action to be taken if the Commission acts to hire the additional legal firm)

The San Mateo County Harbor Commission finds that it is not in the District's best interest to conduct a competitive procurement for these services because of the short time available for input from Board, Staff, and Legal Counsel. The commission further finds that Wittwer-Parkin, LLC has special expertise that will be very beneficial to the District in this matter.

Fiscal Impact: See note to exceed in recommendation. Should the Commission opt for a larger role for Wittwer-Parkin, LLC, the hourly rate is \$285 for partners, \$240 for Senior Associates, \$60 for clerical.

District's General Counsel hourly rate is \$340.

Background: The Municipal Service Review continues the finding of "No sphere of influence" which has been the case for decades. This is not a report which initiates dissolution of the District, but it raises the issue. We want to be sure that the District submits a thorough response.

Responses are due to LAFCo by June 26th, 2015. This is the deadline for the District's response. There is most likely no opportunity to provide written input after that date. The June 17th, 2015 Regular Meeting will include an Agenda item to enable the Commission to choose whether to authorize the President to work with the General Manager, to approve and send the District's response, or to call a special meeting on June 23rd, 2015 to review and approve the District's written response before it is sent.

Whichever process is chosen, I am requesting that if Commissioners have comments they wish to be included in the District's response to LAFCo, such comments be sent to the General Manager by Noon, Monday June 15th, 2015. The official District response will be created from these comments, input from Staff, Legal Counsel, and myself. Should the Commission want to hold a Special Meeting on this topic, a draft will be available for review at that time.
