I asked County Counsel if the Harbor District Board has the authority to switch to district elections by board action. The answer is YES.

Below is County Counsel's analysis.

## Dave

Neither the Harbors and Navigations Code nor the Harbor District Ordinance Code specifies whether Harbor District Commissioners must be elected by district or at large. (Compare Harbors and Navigation Code Section 6240.5, which created the Santa Cruz Port District and provides that its members shall be "elected by the district at large.")

However, the Resolution passed by the Board in 1933 calling a special election for the creation of the Harbor District provided that the District's boundaries would be the entire County and the election Countywide. (See <a href="http://www.smharbor.com/about-the-harbor-district">http://www.smharbor.com/about-the-harbor-district</a>.) The District's website states its members continue to be elected at large (id.), which is consistent with a 2006 San Mateo LAFCO report describing the Harbor District elections as "at large countywide" (see San Mateo LAFCO Report and Recommended Determinations—San Mateo County Harbor District Municipal Service Review and Sphere of Influence Review (Oct. 11, 2006), p. 19).

The Harbor District has the authority to shift from at large to district based elections by resolution, if it so chooses. Elections Code 10650, which just took effect January 1, 2017, provides:

Notwithstanding any other law, a governing body of a special district may require, by resolution, that the members of its governing body be elected using district-based elections, as defined in subdivision (b) of Section 14026, without being required to submit the resolution to the voters for approval. A resolution adopted pursuant to this subdivision shall include a declaration that the change in the method of electing members of the governing body is being made in furtherance of the purposes of the California Voting Rights Act of 2001 (Chapter 1.5 (commencing with Section 14025) of Division 14 of the Elections Code).
